Annual report of the Prudential Committee Chairman:

Operation of the water system was without incident during the calendar year. Although the voters granted Richard Squire a waiver from the moratorium on granting of new shut-offs in the district, he did not make a hook-up to the system because of problems regarding other phases of his proposed project.

Recognizing the need for a more adequate cover for the spring house, the committee has continued to give thought to the matter and has had some preliminary drawings prepared. As soon as more detailed drawings are completed we anticipate putting the work out to bid, and have at least three qualified contractors interested in submitting bids.

we also contemplate having some water in done to the interior of the spring walls, where there is now some contant leakage. The ideal time to attend to this will be while the spring is empty during the roof construction.


If all goes well with the proposed project, we anticipate some additional work to the pump house, specifically some minor work to the roof, a new door of metal construction replacing a badley detriorated wooden plywood door and some long-needed crused some at the approach to the building, which is usually quite wet.

Our relationship with VTC continues on a satisfactory basis. Sampling throughout the year has been with good water quality results. With the college now in possession of the former Langevin property, it has been suggested by Bill DeFlorio, district engineer, that it might be to our advantage to seek arrangement for a right of way to our property along the fence line from Langevin road to our facilities. Being a straight line withvery little grade, it might be a suitable route for wintertime use.

Colleen and Jan have performed their respective duties well, and Pete, Mike and Bill have always been willing and able in their roles as fellow members of the prudential committee. And apparently we continue to enjoy the good will and support of those whose public servants we are—the voters. Our aim continues to be providing a quality product at lowest possible cost.

Report of Prudential Committee:

During 1990-91 the prudential committee undertook and completed the long-planned for project of having a new structure above our spring to replace a building that had served its purpose for more than 50 years. Bids were solicited from area builders and the job was let to Herbert Sargent for the low bid of \$7000, and was completed in a satisface they manner. Part of this job included a new steel door for the pump house to replace a plywood door that was coming apart.

This item was to create a serious problem for us with the arrival of winter. Shrinkage of the door's wood casing, and contraction of the metal war in low temperatures allowed the door latch to slip by the strike, with the result that during a cold snap the door opened and the temperature was beyond the ability of the pump house heater to keep the pumps and piping from freezing. This put the pumps out of commission for a while. Joel Parmlee had Buzz Bowman weld the craked end-plate on one unit and it was in operation within a few days. The second pumprequired a new plate which was ordered, also some new valving, and it was not in running order for about two weeks.

This episode cost us several hundreds of dollars, but was not something that could be anticipated. Needless to say, the pumphouse door is now secured by a lock, a slide bolt and the knob latch, which had been anticipated as a very suitable article.


Other than this situation, the system has operated well, water samplings conducted by the state lab, have been satisfactory. Bill DeFlvio made repairs to the hydrant in front of the old dorm, property of RICHARD Squire was connected to the system on the south end extension.

Looking ahead there are several matters to be considered. Among these is better drainage at the spring and pumphouse, perhps to include drain piping and considerable fill using crushed rock. Foundation work around the pumphouse base. The cement footings were never high enough and and wood rot is progressing. Our maps are inadequate and archaid, and always have been, and a complete set should be re-drawn, and will probably be insisted upon by the new EPA. During the next two years, all water systems, big and small, will be evaluated, and new regulations will go into effect which will probably include filteration and increased sampling schedules. Bonding of the officers will also be important in view of fines they will be liable to under the new EPA policing.

ANNUAL REPORT OF THE PRUDENTIAL COMMITTEE CHAIRMAN RANDOLPH FIRE DISTRICT NO. 1

On November 14, 1991, the Prudential Committee met at the Regan home to loose a new chairman. As you can see, I got the job.

Things went smoothly for awhile until on February 10, 1992 we received a letter informing us that we had an unacceptably high coliform count in our January water samples. As you all know, we were required to give public notice of this high count.

However, thanks to Bill DeFlorio, we had a brand new chlorinator to turn on to remedy the problem. The chlorinator was put into service on February 12 and has remained on since that time.

Harry Wirtz and I met in February with Dick Eithier (VTC) and designed a coliform sampling plan which was drawn up and submitted to the Water Supply Division as required. I have not heard anything from them so it must have been accepted.

On March 18, Bill DeFlorio and I attended a Safe Water Drinking Act Workshop in Berlin where we learned that regulation and water testing requirements are only going to increase. We should be aware of the fact that someday we may be required to install and monitor very expensive filtering equipment.

Among some of the chores accomplished at the pumphouse this year was the installation of a new thermostat and outside strobe light to give warning when the pumphouse temperature gets near the freezing point. Also a number of 'nois were purchased to keep at the pumphouse for unexpected repairs.

We had one incident when a 3 phase breaker on the pole outside the pumphouse tripped, putting the pumps out of service. Luckily, Bill DeFlorio discovered it almost immediately and called CVPS.

Just last Friday, Joel Parmelee dug up and replaced a badly corroded and leaking galvanized tee in the 1 1/2 inch line at Alice LaFrance's shutoff.

Some of the things we need to think about discussing are:

- Installing better drainage around the pumphouse;
- Starting work on a new and complete map of the water system;
- Joel Parmelee informs me that there are 2 shutoffs in the system that no longer operate: one near Lyle Ladieu's and one near Dean Newberry's; and,
 - 4) When we feel we can turn the chlorinator off.

People on the Randolph Center Water System in the Town of Randolph are advised that their drinking water exceeded the Maximum Contaminant Level (MCL) for total coliform bacteria for the month of January 1992.

The United States Environmental Protection Agency (EPA) sets drinking water standards and has determined that the presence of total coliforms is a possible health concern. Total coliforms are common in the environment and are generally not harmful themselves. The presence of these bacteria in drinking water, however, generally is a result of a problem with water treatment or the pipes which distribute the water, and indicates that the water may be contaminated with organisms that can cause disease. Disease symptoms may include diarrhea, cramps, nausea, and possibly jaundice, and any associated headaches and fatigue. These symptoms, however, are not just associated with disease causing organisms in drinking water, but also may be caused by a number of factors other than your drinking water. EPA has set an enforceable drinking water standard for total coliforms to reduce the risk of these adverse health effects. Under this standard, no more than 5.0 percent of the samples collected during a month can contain these bacteria, except that systems collecting fewer than 40 samples per month that have one total coliform positive sample per month are not violating the standard. Drinking water which meets this standard is usually not associated with a health risk from disease-causing bacteria and should be considered safe.

The chlorinator at the Fire District Pump House has been turned on, and will remain on for approximately thirty days as a precautionary measure to correct this problem and to ensure that our water is safe.

RANDOLPH FIRE DISTRICT NO. 1 ANNUAL REPORT OF THE PRUDENTIAL COMMITTEE CHAIRMAN 1992 - 1993

This past year started off on a positive note when we passed the very expensive tests for inorganic and volatile organic chemicals. We came in well below maximum contaminant levels on all chemicals tested for.

On August 6th, Joel Parmelee replaced the 1 1/2 inch valves at both the north and south ends of the 6 inch main; one being in front of Lyle Ladieu's, and the other across the road from Seth Maher's. While they were at it, Lyle put a new shut-off in his service line.

About the same time, a leak was discovered in Seth Maher's service line under the East Bethel Road. Joel also repaired this, adding a new shut-off on the west side of the road and leaving the original shut-off on the east side.

Also about the same time, Dan Langone moved his service line so it would not be under his expanded driveway.

On August 11, we received a letter from the Water Supply Division stating that VTC had forgotten to take the extra water samples in July that were required because of a bad sample in June. We were required to publish a Public Notice of this mistake in the Times-Argus.

On August 24, we sent a letter to our Senators in Washington urging them to pass a bill that will ease off on some of the ever-increasing Safe Water Drinking Act regulations. Regulations such as adding 25 new chemicals each year which we are required to test for. We received encouraging responses from both Senators.

Responding to a complaint from the Center Fire Department, on September 19, Bill DeFlorio and I rebuilt a leaking fire hydrant across from Seth Maher's.

On September 25, Colleen received a letter from Attorney Peter Nowlan stating that it was his understanding that the Catamount property was not in the Fire District and, consequently, did not owe any taxes. I went to his office to discuss the matter, explaining that Alice LaFrance had told me that she informed the owners of the property when they bought it from her that it was indeed in the Fire District. Attorney Nowlan was very polite and said that he would explore the matter further. They subsequently paid the tax bill.

On October 20, the service line at the Wheatley home sprung a serious leak. Bill and I went to locate the shut-off for Jill. We left the shut-off wrench so they could turn the water off when Stan Wheatley came to make the repair.

On October 29, Richard Moses installed a new drainage system around the pumphouse. He also put down gravel for a driveway from the LaFrance property to the pumphouse.

At the same time, Joel replaced the old 1 1/2 inch galvanized steel ipe that pumps into the 6 inch PVC line outside the pumphouse. The new line is black PVC.

On April 7, Joel dug up and repaired another leak in Alice LaFrance's service line, accidentally breaking the 1 1/2 inch main in the process. He added some gravel to the area in hopes of preventing any future leaks.

Some items that will need our attention in the following year are:

- 1) Between July 1 and December 31, we must conduct initial tap water monitoring for lead and copper at 20 sites that contain copper pipes with lead solder installed after 1982. VTC has agreed to take 10 of the samples on the campus, so we must find 10 homes that have copper pipes with lead solder installed after 1982. We must repeat these tests again between January and July 1994. We must also test for nitrate and nitrite before the end of 1993. Some major sources of these chemicals are wastewater, animal feed lots, septic systems, and manured or fertilized agricultural lands.
- 2) If time and funds permit, VTC would like to install a direct pumping line from our pumphouse to the area of the maintenance building.
- 3) VTC plans this summer to completely drain, sandblast and refinish the interior of the water tower. Needless to say, this will be a major disruption to the water system, requiring us to run our pumps almost continuously. The work should take about 2 weeks. We should send a notice to all water users informing them of the need to reduce water use during this brocess.

RANDOLPH FIRE DISTRICT NO. 1 ANNUAL REPORT OF THE PRUDENTIAL COMMITTEE CHAIRMAN 1993-1994

Thin has been a very busy and expensive year.

On June 14, I sent in the samples for nitrate and nitrite testing from which we received good results.

On July 28, Greg Bostock, the Regional Head of the Water Supply Division, came down to inspect our entire system after which he presented us with a nice, long list of new monitoring requirements.

One of the new requirements was testing for lead and copper. The first round we completed on September 2. All samples were under the maximum contaminant level.

On October 10, we conducted our first Microscopic Particulate Analysis. This test involves sending 1000 plus gallons of water from the spring through a filter. The filter is then analyzed to determine if a spring is surface water influenced. The results of the test showed the risk of such influence is low.

On November 10, Joel replaced the shutoffs for both Buddy Braun and Mack Walling. Unfortunately, it turns out that the valve thought to be Braun's was from some unknown abandoned line. Bill DeFlorio used a locating device to trace the pipe from Braun's house to the real shutoff and found it two feet from the one Joel had replaced.

The Prudential Committee met on December 2 to approve plans for the Penny Brook well pipeline replacement. We also discussed buying a second chlorine post and decided against it. Bill said he could get a new one in a day if it was necessary.

A temporary operating permit was issued to the Fire District on January 10. It included demands to record daily water volume amounts and to measure the amount of chlorine in the water each day. These values must be submitted to the State in monthly reports.

Rough use of the fire hydrant in front of Olivet's during the Messier fire on February 3 caused a break in the 1 1/2 inch main north of Ladieu's and in a corroding galvanized fitting in the line to the former Spooner house. The main was repaired on the 4th and the Spooner line on Saturday the 5th.

On February 17, we did a required Radionuclide test which proved to be well within safe levels.

March 26 found Bill DeFlorio repairing another leak. This time in the 1 1/2 inch line to the Firehouse in front of Harry Wirtz's home. Bill said the line was of very poor quality and breaks easily.

The major expense of the year started on April 7 when work began on the line that served Sarah Dupras and Esther Nelson. Bill DeFlorio and Joel Parmelee, with the help of Duane Salls, dug it up to find that the main leak was under Route 66. The next day, Joel tried to flush a line under the road using water pressure, but was unsuccessful after getting about halfway under.

**Issequently, Bill called in a crew from the Lamoille Construction Company and, on the 15th, they succeeded in boring a 6 inch steel casing under the road through which was placed a new 3 inch ductile iron pipe. On the 18th, the job was finished with a new 1 inch copper line from the 3 inch pipe to the junction of the Dupras and Nelson lines.

On April 9, we received our first permit to operate fee. The bill for 3 mor is is \$128.94. We should discuss how VTC should share the cost of this fee.

On April 19, Joel Parmelee dug up the 1 1/2 inch main past Ladieu's where it had broken in February to reattach Floyd Fuller's line since a test of his well water showed its bacteria level too high to be safe. Unfortunately, when Floyd's line was turned on, it leaked badly in several places. Consequently, on May 9, a new 1 1/2 inch line was layed from the new 3 inch line under Route 66 south on the east side of the road to in front of Floyd Fuller's house and a new service to the house was installed. The cost of this work was shared by Mr. Fuller and the District since the 1 1/2 inch line could sometime serve other houses.

On April 26, Bill DeFlorio located the shutoff to the Church and Joel, with the help of a welder, thawed the pipe which had been frozen for sometime.

On May 3, we received results from our spring edition of the Microscopic Particulate Analysis which was conducted on April 12. Again, it showed low probability of surface water influence.

On May 13, a small leak at Bill Dowd's shutoff was fixed by Joel Parmelee.

And finally, on May 13 the samples for our second round of lead-copper tests were delivered to the lab by Colleen. The results have not yet been received.

I/ms of concern for the upcoming year include:

- 1) The new Phase II and Phase V chemical testing program which, over the next 9 years, is estimated to cost the Fire District at least \$12,000. We must also conduct a test for asbestos.
- Sometime soon, VTC will be installing a new 6 inch main that will run from near the maintenance building to connect with our 6 inch main behind the Firehouse. During this work, we hope to install a new fire hydrant next to the Firehouse.
- We need to make a concrete decision on where Fire District-owned water lines end and Homeowner-owned lines begin so that future billings for work performed will be consistent.
- We are required to submit to the Water Supply Division a Source Protection Plan which, among other things, is a comprehensive study of all sources of pollution within a 3,000 foot radius around our spring.

Dear Neighbors:

I thought I'd send a note along with the bills in order to let you keep about some of the things that have been going on in the water system and to show where some of the money goes.

The Safe Drinking Water Act passed by the U.S. Congress has added many new restrictions, regulations and expenses to public water systems. Some of the new tests we have conducted this past year include the following:

So far, the results of all of these tests have been good. However, we must repeat all of these tests again this year. If we fail any of them, we will be required to install expensive new treatment equipment.

I would like to thank Carolyn Lumbra, Harry Wirtz, Jan Floyd, Jill Wheatley, Carol Squire, Dan Langone and Ennis Daniel for helping with the . Ad and Copper Test, and Colleen for delivering the samples to the labs in Burlington and Essex Junction.

I would also like to thank Bill DeFlorio for all of his help. Bill is the person who really keeps the hardware in this system going.

The Randolph Center Water System, a public water system under the laws of the State of Vermont, was issued a Temporary Operating Permit on January 10, 1994.

The Randolph Center Water System is actively working to replace the transmission main from the Penny Brook Well to the Vermont Technical College distribution system including the installation of a length of large diameter pipe to achieve the required minimum disinfectant contact time, to install a watertight cap on the Penny Brook Well, to construct a barrier surrounding the isolation area for the Penny Brook Well, to develop an Operations and Maintenance Manual, and to start development of a Source Protection Plan.

I would love to see everyone at the Annual Fire District (Water System) Meeting that takes place every year on the third Tuesday in May. This year, that's May 17th, at the Fire House at 7:00 p.m.

Dear Neighbors,

For the past several years, it has not been necessary to increase the amount we charge ourselves for maintaining the water system. However, because of increased water testing required by the Safe Drinking Water Act, we must raise the basic water rent from \$25.00 (semi-annual) to \$40.00. This amount covers one household plus one person; each additional person adds \$5.00. The tax rate goes from 8¢ to 9¢ per \$100.00. This only increases our revenue by about \$2,600.00 per year.

Water testing expenses this past year totalled \$1,811.09. New Phase II/V required testing for harmful chemicals will add approximately \$1,400.00 per year for the next 9 years. Another added cost has been a new tax levied on the water district by the Vermont Water Supply Division to cover the administration costs of the Safe Drinking Water Act. The amount of this tax is 2¢ per 1,000 gallons of water used, which amounts to an additional expense of \$500.00 per year. Incidentally, VTC so far has declined to pay any part of this tax, even though they use more than half of the water pumped in this system.

Maintenance, repairs and upgrades have also been extremely expensive this year. From May 1, 1973 to date, they amount to approximately \$19,000.00. Necessary improvements which we will be adding to the system this summer will include a new fire hydrant for the fire station; replacing the old and brittle 1 1/2-inch plastic pipeline (it broke last winter) between Lyle Ladieu's and Alice LaFrance's, installing a new 6-inch ductile iron pipe; and, adding a new fire hydrant near Alice's.

Despite all this, our water is still cheaper and of far higher quality than that of Randolph Village.

I am writing on behalf of the Randolph Fire District #1 to request that we be given \$13,000 from the Community Development Action Grant Program for improvements to our water system.

As was stated in the meeting at Bolton Valley in November of 1988, and the 1988 Randolph Town Report, the money from this fund was to be set aside for capital improvements in the Town. We would like to use \$13,000 of this fund for capital improvements to the Randolph Fire District #1's water distribution and fire protection systems. We are planning to add two (2) fire hydrants and replace 700 feet of 1.5 inch plastic pipe with a 6 inch pipe and add 150 feet of new 6 inch pipe to the fire house, to replace the 1.5 inch plastic pipe that runs 1500 feet down Furnace Street. As is required by the Grant Program, these capital improvements would benefit water district residents of all income levels who are, or will be, on the system.

ANNUAL REPORT OF THE PRUDENTIAL COMMITTEE CHAIRMAN RANDOLPH FIRE DISTRICT NO. 1 1994-1995

Fortunately, the sight of water gurgling up through the ground where it shouldn't be was a less frequent occurrence this past year.

On July 14th, a new fire hydrant was installed next to the firehouse while VTC was installing a new 6-inch line from in front of the Maintenance Building connecting to our 6-inch line coming from the spring pumphouse.

On July 15th, a water sample was taken from the cemetery hydrant to check for asbestos. None was found. This required test cost \$225.00.

On July 22nd, water testing continued with samples taken from the spring for Volatile Organic Chemicals. None were found.

July 25th dawned with Bill DeFlorio supervising the installation of a new 6-inch ductile iron pipe from in front of Lyle Ladieu's, north to Alice LaFrance's. This line replaced an old, brittle 1 1/2-inch plastic line. A new fire hydrant was installed in front of Alice's, at the end of the line.

On August 2nd, I went to meet with Bruce MacDonald of Vermont Pure to explain why they owe us taxes and how to withdraw from the Fire District if they so desire.

On October 7th, the Randolph Center School connected a 4-inch ductile pipe to the 6-inch main in front of the School to charge their new sprinkler system.

Thanks to very helpful persuasion from Bill DeFlorio, Al Floyd and Wes Herwig, the Randolph Selectmen voted to grant the Fire District \$10,000.00 for infrastructure improvement. The check was received on November 2nd, just in time to keep the checkbook from going into the red.

On December 15th, the Water Supply Division granted us a 3-year Permit to Operate. Before the three year period is up, we must complete an Operation and Maintenance Manual and a Source Protection Plan.

On February 12th, I took samples from the spring for the first round of Synthetic Organic Chemical testing. These tests cost over \$900.00.

While taking the monthly meter reading on March 1st, I discovered that the utility pole outside the pumphouse had shorted, partially burning the pole and leaving the pumphouse without 3-phase power. Bill DeFlorio called CVPS and the pole was replaced the following day. Thanks to Pierre LaFrance for clearing a road through the snow using the Daniel's snowblower.



On April 6th, I took more spring samples for Volatile Organic and Inorganic Chemicals and Nitrate tests. Water testing so far has found no contaminants exceeding maximum contaminant levels.

On April 10th, I received a letter from Vermont Pure stating that they were withdrawing from the Fire District and were not paying the taxes owed.

On April 12th, I went to see Peter Nowlan to discuss the Vermont Pure situation. He subsequently sent them a letter explaining in detail the procedure they must follow to withdraw from the District, and the fact that they must pay the taxes owed, including interest and penalty. As of this date, we still have not received any tax payment or a proper legal notification and request for the Fire District to have a vote on their withdrawal.

CHAIRMAN'S REPORT RANDOLPH FIRE DISTRICT NO. 1 ANNUAL MEETING MAY 21, 1996

The year of the nursing home dilemma started off with a meeting on June 14th with Tom Windgardner, Dave Anderson, Bill Davidson and Terrian Manning at the Hospital. The water requirements of the nursing home was the subject of the meeting, at which the Fire District agreed to yield test our spring at Gifford's expense.

Unfortunately, the June water sample turned out to be coliform positive. We were required to issue a boil water notice on June 22nd and also met with Dr. Clark at VTC that day to discuss the situation. After taking water samples from several locations in the system, it was determined that our spring was the source of the contamination. So we turned up the chlorinator and, after obtaining clean sample results on 3 consecutive days, were able to rescind the boil water notice on June 24th.

While all of this was going on, our spring was tested for yield on June 23rd.

July 6th turned out to be a happy day when, during a specially-called meeting of the Fire District, the request of Vermont Pure Springs to be removed from the District was granted by unanimous vote.

On July 10th, the VTC well pump broke down. We began pumping from the Fire District spring for 16 hours a day until July 25th, at which time we cut back to 14 hours a day. The VTC pump was finally back on line on July 27th.

The Fire District had to supply water to VTC again from August 28th to September 1st while the VTC well was being yield tested.

On October 11th, we met with officials at Gifford and with Richard Vandenberg of Lincoln Applied Geology to discuss the results of the yield tests of the Fire District spring and the VTC well.

The VTC pump broke down again on November 18th. This time we pumped for 10 hours a day until November 29th.

On March 7th, we received permission from the Water Supply Division to change our coliform testing plan. Dick Ethier at VTC had asked me to make the request so that the Fire District does most of the summertime sampling.

On April 1st, I took water samples for required Nitrate and Cyanide tests. Results for both were well below maximum contaminate levels.

April 22nd turned out to be a rather embarrassing day for a certain auger operator working for the L & D Marking Co. Where he wanted to put a new road sign post turned out to be a place already occupied by our 6-inch water main. Thanks to a very rapid response from Bill DeFlorio, Joel Parmelee and Isaac Salls, the main was repaired and back on line by 8:00 p.m. that evening.

Items that need attention during the upcoming year include:

- We must work on and hopefully complete our required Source Protection Plan and our Operation and Maintenance Manual. Both of these items must be complete before we can be granted a renewal to our Permit to Operate in a little over a year's time.
- Again this year, VTC has said that they hope to be performing major maintenance to the water tower which will require us to curtail our water usage as much as possible.
- Finally, this year we need to take 10 more Lead and Copper samples during June.

RANDOLPH FIRE DISTRICT NO. 1 CHAIRMAN'S REPORT May, 1998

It's been a fairly routine and tranquil year in the District.

On June 6th, 1997 Joel Parmelee repaired the leak at the Kessler shutoff. The cause was a cracked fitting on the customer side of the shutoff.

A low chlorine reading at our house caused me to go check things at the pumphouse on July 4th. I found the main breaker up on the utility pole had been tripped apparently by the lightning storm that had occurred a day or two earlier. It took five trips by CVPS to correct the problem.

While removing a broken three-phase breaker at the pumphouse, we accidentally damaged the old chlorinator when we unknowingly connected it to the "wild" leg of the three phase. This gave us a good excuse to get a new chlorinator, since the old one had become somewhat unreliable. The new one has an automatic air bleed device which makes it much less prone to becoming airlocked which was a regular occurrence with the old pump.

On September 16th, 1997, Dennis Regan and Bill DeFlorio wired the new exhaust fan at the pumphouse so it can be turned on even when the pump is not running.

On October 26th, 1997, I repaired the Maher shutoff again after the realtor ran over it. This time I placed it at ground level, since it is so close to the road.

November 1st, 1997 was a terrible day because of the John Osha barn fire. Bill and I manned the hydrant to keep the fireman from slamming the valve off too fast, which has happened in the past.

On November 3rd, 1997, Shorty Emmons had a flooded cellar because a piece of firewood had fallen and broken his pipe. He had a frantic time finding the shutoff wrench but was rescued by Trudy DeFlorio who found it for him. Bill was away working in Tunbridge. We have now purchased an extra wrench which is kept at Floyd's Store.

We received great news on December 30th when the Water Supply Division approved both our Source Protection Plan and our Operation and Maintenance Manual. Bill DeFlorio did a fantastic job on our Operation and Maintenance Manual which was accepted with no questions asked. It includes a super map of the Water District hardware.

On January 19th, 1998, I took samples for the Volatile Organic Chemical tests and on January 17th, 1998, samples for Synthetic Organic Chemicals, the cost of which has now increased to \$1,140.00.

On January 28th and 29th, 1998, Bevins Roofing installed new vinyl sing with foam insulation and standing seam roofing on the pumphouse.

On March 15th, 1998, I took samples for Nitrite and on April 22nd, 1998, I took samples for the Inorganic Chemical Tests. So far this year, all test results have been below Maximum Contaminant Level.

On May 3rd, the chlorinator at the pumphouse quit, and we had to stop pumping. The next Saturday, May 9th, 1998, Bill DeFlorio and I rebuilt the chlorinator and we began pumping again, increasing to six hours a day to makeup for time down.

Last Monday, May 11th, 1998, Jill Wheatley discovered that the area around her shutoff was very wet. Bill investigated and determined the leak to be just past the shutoff. Joel is scheduled to repair the leak this week.

Items on the agenda for the coming year include:

- 1. It's our turn to take the ten (10) Lead and Copper samples this summer.
 - 2. We need to give the Reservoir cover a fresh coat of paint.

Dear Fire District Residents:

The Randolph Fire District No. 1 has been asked to study the possibility of funding a preliminary engineering study to determine the feasibility of building a sanitary sewer line beginning at the Main Entrance to Vermont Technical College and going North along the Ridge Road to the Russell Mills residence.

An informational meeting will be held on December 16, 1998 at 7:00 p.m. at the Randolph Center Fire Station to discuss this matter. Three representatives from the State of Vermont Agency of Natural Resources and a representative from the Rural Community Assistance Program will be at the meeting to answer questions and give advice.

The estimated cost of the preliminary engineering study is \$5,500. The estimated cost of the sewer line construction is between \$100,000 and \$220,000. State and Federal grants may be available to cover approximately one-third of the construction costs. The remainder of the costs would be borne by the Randolph Fire District No. 1 members and Lake Champagne Campground.

In 1997, the State of Vermont required that the Randolph Fire District No. 1 create a Wellhead Protection Area around the existing spring to protect the water source. Septic systems within the Wellhead Protection Area are a possible source of contamination. Lake Champagne Campground has existing septic systems within that Wellhead Protection Area. The State of Vermont has determined that two of those systems have failed. The LaFrances have requested that the Randolph Fire District No. 1 consider the construction of a sewer line that would serve the Campground. The sewer line could also serve those homes in the Wellhead Protection Area.

Voting will be to decide if the Randolph Fire District No. 1 should borrow \$5,500 to fund a preliminary engineering study. Voting is limited to residents of the Randolph Fire District No. 1 who have resided in the Fire District for at least one year and are also registered voters in the Town of Randolph.

Voting will take place on January 8, 1999 at Floyd's General Store from 12:30 p.m. to 6:00 p.m. and from 7:05 p.m. to 8:30 p.m. Absentee ballots are available by calling Jan Floyd at 728-5333 or Colleen Regan at 728-9869. Absentee ballots must be postmarked by January 8, 1999.

Voting results will be posted at Floyd's General Store and at the Randolph Center Post Office.

RANDOLPH FIRE DISTRICT NO. 1 CHAIRMAN'S REPORT MAY 1999

I think it is safe to say that the officers of the Fire District earned their \$100.00 this past year.

On May 23, 1998, Bill DeFlorio repaired a leak in the 1 1/2" line near Richard Squire's house. The line was leaking where the Wheatley line tees off and also where there is a plug at the end of the line.

On May 26, 1998, Pierre LaFrance called to inform us that he had a failed septic system at the Campground that was within the Wellhead Protection area. He requested that the Fire District look into the possibility of getting funding to extend the sewer line up the Ridge Road. On June 4th, I sent a letter to Eric Blatt at the Facilities Engineering Division, State of Vermont, requesting information on sewer funding.

On June 9, 1998, I met with Pat French down at the Town Offices regarding his work on our behalf to receive payment in lieu of taxes for State buildings that are in the Fire District. I took along a map of the Fire District so we could determine exactly which buildings were in the District.

On June 16, 1998, the Prudential Committee met to work on the Water Rule which is nearly complete. I need to work on getting the boundary description completed and draw it on the map. We also discussed the LaFrance septic problems and decided to pursue all the possibilities to acquire funding for a possible sewer line extension.

On July 2, 1998, Bill DeFlorio, Carolyn Lumbra, Pierre LaFrance and I had our first meeting with Tom Clark at the Campground. Tom is with the Rural Community Assistance Program, and he agreed to help us look into the possibility of a sewer line extension up the Ridge Road.

On August 7, 1998, Bill DeFlorio had a new gas space heater installed at the pumphouse in addition to the existing electric heat. We now have two heating systems in case one should fail.

On September 9, 1998, the Prudential Committee met to discuss a request from Vermont Pure to sell them water from our spring. We decided that this would not be possible, and we sent a letter to Vermont Pure informing them of our decision. A copy of the letter was posted at Floyd's Store and at the Post Office.

On September 25, 1998, Bill repaired a leak at the shutoff to Alice LaFrance's barn. He disconnected the line completely because Alice said she no longer needed it. Also on that day and the next, Joel Parmelee replaced his water line from the main to his building on Route 66 and to Farnham's Auto Body Shop.

On October 10, 1998, Bill DeFlorio and I replaced a leaking brass fitting at the pumphouse. The fairly new valves in the pit where the 6-inch VTC line tees into our 6-inch pumping line made draining and refilling the line from the pumphouse much easier than in the past when we had to use the valve all the way up on Main Street.

On October 16, 1998, Carolyn Lumbra, Pierre LaFrance, Tom Clark and I met with the Randolph Village Sewer and Water Committee to inform and ask questions about our possible extension of the sewer line up the Ridge Road.

Jan Floyd, Harry Wirtz, Bill DeFlorio and I met with Tom Clark again on October 27, 1998. We discussed possible costs, funding and design for the sewer extension.

On November 17, 1998, we had another sewer meeting with Pierre LaFrance, Tom Clark, Harry Wirtz, Carolyn Lumbra and I attending. Also

present at this meeting was Bob Harrington. Bob has worked in the past with Tom and was working with Pierre LaFrance on the possible solutions to his sewer problems.

On December 1, 1998, Harry Wirtz, Carolyn Lumbra and I met at my home to compose a letter to the Fire District members to inform them of the informational meeting about the possible sewer line extension on December 16, 1998. We also set January 8, 1999 as the date for the District to vote on spending \$5,500 on a preliminary engineering study of the sewer line extension.

On December 16, 1998, the informational meeting took place. Present to answer our questions were Tom Clark and Bob Harrington and from the State came Eric Blatt and Nopadon Sundaraghaya. The meeting was somewhat difficult at times but, in the end, helpful and informative.

Getting away from the sewer thing for a second, at the end of December we received a check from the Town of Randolph in the amount of \$703 for payment in lieu of taxes for state buildings in the Fire District. We thank Pat French very much for his efforts on our behalf.

On January 8, 1999, we had the big vote. With over 80 percent voter turnout, the results were 45 to 12 opposed to funding the engineering study. I want to thank all the officers of the Fire District for their much appreciated help with this endeavor.

On February 16, 1999, we received a new Permit to Operate which is good for a period of five years. We also received the results of our recent Sanitary Survey. They could find no fault with our water system.

On February 28, 1999, Bill DeFlorio and I rebuilt the chlorinator at the pumphouse. We also replaced with PVC the iron fittings where the chlorine enters the pumping line. The iron had a bad habit of clogging with crystalized chlorine.

On March 19, 1999, we received notification from the Water Supply Division that we are now required to issue an Annual Consumer Confidence Report to everyone in the District. I am scheduled to attend a class on May 26, 1999 in Waterbury to learn how to prepare this report.

With regard to water tests this past year: In addition to the monthly bacteria test, we have tested for Inorganic Chemicals, Nitrate, Volatile Organic Chemicals, and Lead and Copper. All test results have been below maximum contaminant level.

Items on the agenda for the upcoming year include:

1. Work on Water Rule

2. Try to get a coat of stain on the Reservoir cover
